Maximum limit of one entry per Entrant per Fan Compass Account, regardless of method of entry. There is the option to provide the entrants with one (1) extra entry by listing their Konami username. All entries must be received by the end of the Sweepstakes Period to be valid. Incorrect or incomplete entries are void.
