Prinx Tires Family Game Day Kit Sweepstakes

Maximum limit of one entry per Entrant per Fan Compass account, regardless of method of entry. There is an option to share on the entrant’s Facebook, X, email or text for ten (10) extra entries via each method of sharing, for a maximum of 41 entries per submission. All entrants must follow @PrinxTiresUSA on Instagram for their entry to be valid (Entrant must share Instagram Handle for verification).
